## **Introduction**

This curriculum for the Master of Music programme (Music Performance) has been compiled pursuant to section 39 of Executive Order no. 1324 of 23 November 2023 on the Academies of Music and the Opera Academy and section 20 of Executive Order no. 1244 of 11 December 2009 on Marking Scales and Other Forms of Assessment at Certain Educational Institutions under the Danish Ministry of Culture (hereinafter referred to as the Assessment Order).

The curriculum shall enter into force on 30 April 2024 and shall apply to all Masters students who commence their study programmes in August 2023 or later.

## 1. Title, entrance requirements, admission

### *1.1 Title*

Graduates of the Master of Music programme are entitled to use the Danish academic title cand. musicae (Music Performance).

In English, the title is Master of Music (MMus) (Music Performance).

### *1.2 Entrance requirements and rules for admission*

The entrance requirements for the Masters programme are:

- A passed Bachelor of Music (Music Performance; Composition, Music Production) taken at RMC;
- a passed bachelor in music (Songwriting), taken at RMC;
- a passed bachelor in music (Sound Engineering), taken at RMC;
- a passed and relevant Bachelor study programme from another Danish music conservatory, or
- a passed and relevant Bachelor study programme from a foreign music conservatory.

Based on a specific assessment, the conservatory may recognise other artistic based Bachelor study programmes in music as qualifying for admission.

#### *Admission*

All applicants who meet the admission requirements are tested at an entrance examination.

The number of students the Conservatory can admit to its Masters courses is subject to a quota, and the admission decision will be based on a concrete assessment of the applicant's abilities and skills.

The entrance examination comprises the basis for assessment.

Together with the application, the applicant submits:

- a study project plan, in which applicants, on the basis of the learning outcomes of the Masters programme, formulate their own individual goals in taking the programme, including their own learning requirements in order to fulfil their ambitions;
- personal portfolio.

#### *The entrance examination*

- Practical examination in performance;
- Personal interview.

The assessment basis consists of the applicant's practical examination in performance, the applicant's personal portfolio, the applicant's study project plan and the personal interview.

In the assessment, emphasis is placed on:

- the applicant's artistic and academic standard;
- the applicant's study project plan.

## 2. Programme aims and learning outcomes

### 2.1 Programme Aims

The programme qualifies graduates at an advanced level to work as a creative and performing musician within the field of contemporary rhythmic music.

The aim of the Masters programme is to augment the student's Bachelor study programme with further studies within the field of creative and performing musicianship.

The programme also focuses on enhancing the knowledge, skills and competencies of students, to enable them to manage their own careers in a changing employment market.

### 2.2 Programme Learning Outcomes

Pursuant to the applicable Danish qualifications framework for programmes of higher education, the learning outcomes for the study programme are formulated in three general categories:  
*Knowledge*, which describes the student's knowledge and understanding;  
*Skills*, which describe the student's central abilities;  
*Competencies*, which describe the student's personal and independent application of knowledge and skills.  
The goals for learning outcome describe the student's anticipated benefit from the programme at the conclusion of the learning process.  
The focus is on the learning process and on each student's learning outcomes, rather than on the intention of a particular teaching or teacher.

At the conclusion of the Masters programme, it is expected that the student will have achieved the following learning outcomes at an advanced level:

#### 2.2.1 Skills

The Masters graduate will:

- be capable of creating, performing and communicating music and musical experiences borne by an independent artistic expression;
- possess performative, creational, instrumental/vocal and other professional skills that develop and support the student's artistic profile as a creative and performing musician;
- possess the ability to make and justify individual and collective choices in relation to creative and/or performance products;
- be able to place his or her own artistic practice in a national and international context;
- be capable of handling communication activities in relation to colleagues and non-specialists on the basis of his or her own artistic development;
- possess skills in relation to creating and strengthening his or her employment as a creative and performing musician.

#### 2.2.2 Knowledge

The Masters graduate will possess:

- knowledge that develops and supports the student's artistic profile as a creative and performing musician;
- knowledge of method and practice within artistic developmental work;
- knowledge of method and practice with the performative area;
- the ability to reflect critically on artistic processes and results;
- knowledge of how to turn ideas and possibilities into value;
- knowledge of the employment market and employment prospects within the field of rhythmic music.

### **2.2.3 Competencies**

The Masters graduate will be able to:

- formulate, initiate and implement professional and interdisciplinary tasks and projects in a professional context, both independently and in collaboration with others;
- plan and carry out complex developmental tasks that demand new and innovative solutions;
- give and receive professionally based criticism in relation to both working processes and products;
- be capable of taking independent responsibility for his or her own professional development and specialisation.

## **3. Structure and subject areas**

### **3.1 Study Plan**

The Masters programme corresponds to 120 ECTS points, equivalent to two years of full-time study. A year of full-time study includes teaching, independent study, examinations and all other study-related activities.

The location of the subjects, and their ECTS values, are shown in the figure below.

### **3.2 Course Registration**

The programme is organized in a progressive academic sequence and each student is automatically registered for courses in accordance with the programme curriculum.

### **3.3 Criteria for participation**

Any special criteria for participation will be set out in the course plan for the individual subject or project.

### ***3.4 Organisation of the teaching***

The teaching is mainly provided within a particular year group; however, the subjects and projects may also be provided in classes of students drawn from various years and/or study programmes.

Before a year of study commences, a *course plan* is compiled for each subject or project. For each subject or project, the course plan contains information on its organisation, credits, premises and equipment, and class composition. In subjects where assessment is based on attendance at classes, etc., the course plan will include specific requirements towards assignment submissions and/or presentations.

The course plan is approved by the Principal and may be viewed on the Conservatory's intranet at the start of the semester.

## **4. Assessment**

### ***4.1 Object***

The object of assessment is to evaluate whether the student's qualifications comply with the programme's learning outcomes.

### ***4.2 Rules for assessment***

At the Rhythmic Music Conservatory (RMC), assessment of the student's qualifications can take place in three ways:

A. Assessment on the basis of examinations at which the student's proficiency is assessed by teachers, possibly supplemented by internal and/or external examiners. The assessment awarded is a grade from the seven-point scale, possibly supplemented by a written statement, or the assessment Approved/Not approved.

B. Assessment on the basis of a submitted assignment, where the student's proficiency is assessed by teachers, possibly supplemented by internal and/or external examiners. The assessment awarded is a grade from the seven-point scale, or the assessment Approved/Not approved.

C. Assessment on the basis of the student's active subject-specific participation in the course. The assessment awarded is Approved/Not Approved.

### ***4.3 Other provisions***

All subjects must be passed before a diploma can be issued for a successfully completed study programme.

Students who depart the study programme without completing it are entitled to documentation indicating in ECTS points the parts of the study programme that have been passed.

The programme is organised in a progressive sequence, and each student is automatically registered for assessment in accordance with the student's location in the study programme. In the process of the composition of examination panels, it must in the planning be ensured that all students at the same assessment in the same subject are dealt with equally in terms of the participation of their own teacher in the examination panel.

#### 4.5 Calculation of standard pages

Where subject descriptions refer to the size of the syllabus or written assignments, the pages referred to are in all cases standard pages of 2,400 keystrokes (including spaces). The front cover, table of contents, bibliography and appendices do not count towards the size of the written assignments.

Written assignments may deviate from the specified number of pages by at most +/- 10%.

## 5. Other provisions

### 5.1 Language

The language of instruction is usually Danish, but teachers may provide teaching in English to individuals or small groups as necessary.

RMC also offers selected courses in English. The course plan will state the language in which each of the courses is taught.

Non-Danish-speaking students may choose to write their assignments or take their examinations in one of the other Scandinavian languages, or in English.

### ***5.2 Rules for practical training***

The practical elements of the study programme are described in the subject descriptions and course plans for the subjects.

### ***5.3 Rules for credit transfer***

#### *5.3.1 Equivalence*

Approved programme elements taken at an academy that offers a study programme under the Education Order are equivalent to corresponding programme elements at other academies that offer the same programme of study.

#### *5.3.2 Credit agreement*

Credit for programme elements may be obtained under the academies' joint credit agreement.

#### *5.3.3 Other credit*

Study programme elements passed as part of another non-completed Danish or foreign course of higher education may substitute for study programme elements covered by the Education Order, subject to the decision of the Conservatory in each individual instance, or in accordance with rules laid down by the Conservatory.

### ***5.4 Disciplinary measures***

Students at Rhythmic Music Conservatory are subject to the Conservatory's rules of conduct. Students are required to be familiar with and keep themselves informed of the rules. The rules of conduct may be viewed on the Conservatory's intranet.

### ***5.5 Attendance***

Attendance is compulsory at tuition and related activities at the Conservatory. The Conservatory shall lay down specific regulations for procedures and sanctions towards students who fail to observe the Conservatory's rules for attendance. The rules for attendance may be viewed on the Conservatory's intranet.

### ***5.6 Evaluation***

The study programme is subject to continuous evaluation through systematic evaluation procedures. The Conservatory shall lay down the specific procedures for the evaluations.

### ***5.7 Exemptions***

The Conservatory may grant exemptions from any rules in the curriculum that are determined solely by the Conservatory.

## 6. Subject descriptions

### *Subject description: Artistic Development Work (ADW)*

For the performing rhythmic musician, it is essential to develop an independent artistic expression and a strong performative and creative profile, which will comprise the core of the musician's future professional practice.

The subject Artistic Development Work comprises the central element of the programme, in which the student, in a process and product-oriented practice, develops an independent, sophisticated artistic expression, with the emphasis on the performative aspects. The academic progression consists of both individually and jointly controlled projects and includes a central element of reflection.

### **Learning outcomes**

At the conclusion of the teaching in Artistic Development Work in the second semester, the student must, at an advanced level:

- be capable of creating, performing and communicating music and musical experiences borne by an independent artistic expression;
- possess musical, instrumental/vocal and other professional skills that develop and support the student's artistic profile as a creative and performing musician;
- possess knowledge of methods and practice within live performance;
- be able to apply artistically qualified formats for performance and presentation, supporting the artistic profile of the student;
- possess the ability to make and justify individual and collective choices in relation to creative and/or performance products;
- possess skills in relation to creating and developing music and/or musical experiences as a creative and performing musician;
- possess knowledge that develops and supports the student's artistic profile as a creative and performing musician;
- possess knowledge of method and practice within artistic developmental work;
- be able to place his or her own artistic practice in a national and international context;
- be able to reflect critically on artistic processes and results;
- be capable of handling communication activities in relation to colleagues and non-specialists on the basis of his or her own artistic development;
- be able to formulate, initiate and implement professional and interdisciplinary tasks and projects in a professional context, both independently and in collaboration with others;
- be capable of giving and receiving professionally based criticism in relation to both working processes and products;
- be capable of taking independent responsibility for his or her own professional development and specialisation.

### **Content**

The subject Artistic Development Work consists of two independent elements:

1. Artistic developmental work
2. Theme courses

*Artistic development work*

The teaching is based on the individual student's artistic production and performance, and includes the following areas:

- Live performance, including planning and realisation of concerts;
- Work creation through composition, improvisation, arrangement and/or production;
- Artistic idea development;
- Contextualisation – being able to place one's own artistic practice in a national and international context;
- Oral and written reflections on the process – artistic choices and methodology, dialogue with networks and professional environments, etc.
- Oral and written reflections on the result – result in relation to intention, etc.
- Communication of reflections on artistic processes and results to colleagues and non-specialists;
- Planning, implementation, presentation and evaluation of creative and performing projects and project processes.

*Theme courses*

The student also attends a number of brief courses of up to one week's duration in:

- Composition
- Artistic management
- Improvisation
- Ensemble playing

## Assessment

1. Semester assessment ultimo 1<sup>st</sup> semester

The examination must be passed before the study programme can be deemed to be completed.

## Examination description

### *Content*

The examination consists of a presentation in two parts:

- Presentation: The student presents his/her work of the semester with a focus on own, artistic development. The presentation can be a live performance or by playing recorded music.
- Reflection: The student orally presents his/her own reflections in relation to his/her work in the semester, hereunder reflection on working methods and results of these, course contents, own evaluation of the artistic/musical results achieved and on focus areas in the following semester.

### *Duration*

- Presentation, 15 minutes
- Reflection, 10 minutes
- Assessment, 10 minutes
- Disclosure of examination result and explanatory interview, 10 minutes.

### *Assessment*

- A grade from the seven-point scale is awarded for the presentation, and a further grade from the seven-point scale is awarded for the reflection; in order to pass the exam, both parts of the exam must be passed separately.
- The assessment basis consists of the student's presentation and reflection.
- The assessment is based on an overall evaluation of the extent to which the examination performance meets the learning outcomes for the subject.
- In the assessment, emphasis is placed on the student's artistic and academic standard, and on the student's ability to reflect.

### *Examination panel*

The examination panel consists of a common internal expert and a second common internal expert (examination supervisor).

Pursuant to section 13 of the Assessment Order, the common internal expert acts as "moderator", while the second common internal expert (the examination supervisor) act as "examiner".

### *Form*

- Individual examination.

2. Concluding Masters examination, ultimo 2<sup>nd</sup> semester

The examination must be passed before the study programme can be deemed to be completed.

### **Examination description**

#### ***Content***

The examination consists of an external group presentation (a minimum of three students per group) of a self-selected repertoire, being a part of a collectively planned study year group presentation, in which the student is contributing with live performance in parts of the music presented.

The presentation can take place as a concert, a display, an exhibition, a performance or similar. Each student may participate in several presentations but is solely assessed on the basis of one specific presentation, indicated in advance.

A maximum of eight students can be assessed on the basis of the same presentation.

Before the exam, the student compiles a written reflection.

#### ***Duration***

- Presentation in accordance with a collectively planned programme. Each student is assessed solely on the basis of one specific presentation, indicated in advance and with a duration of 20 minutes.
- Interview, in which the examination panel can ask questions related to the presentation and to the student's written reflection; 10 minutes per student;
- Assessment process 10 minutes per student;
- Disclosure of examination result and explanatory interview, 10 minutes;
- Initial assessment process 60 minutes per day of presentation.

#### ***Assessment***

- The presentation is awarded with the assessment Approved/Not Approved for the group performance and with the assessment Approved/Not Approved for the written reflection; both parts of the exam must be passed separately;
- The assessment basis consists of the in advance indicated group presentation in which the student has participated, the interview and the student's written reflection;
- The assessment is based on an evaluation of the extent to which the examination performance meets the learning outcomes for the subject;
- In the assessment, emphasis is placed on the student's ability as artistically responsible to perform, create and communicate a music experience in the room, on the student's artistic and professional level, on the student's ability to develop and carry out collaborative, creational projects in a professional context in collaboration with others as well as on the student's ability to reflect.

#### ***Examination panel***

The examination panel consists of a common external expert and a common internal expert (examination supervisor).

Pursuant to section 13 of the Assessment Order, the common external expert act as “moderator” and the common internal expert (the examination supervisor) act as “examiner”.

***Form***

- Individual assessment with group presentation and individual written reflection to be planned so that interview, assessment process and disclosure of examination result and explanatory interview is taking place one to three days after the presentation;
- The collectively planned programme must be submitted appr. one week prior to the examination. The precise deadline for submission will be set by the Study Administration and stated in the relevant course plan.
- The collectively planned programme is compiled by the student cohort jointly in accordance with requirements, set by the Study Administration beforehand, indication of which group presentation that is to form the basis of assessment for each student included;
- The examination is carried out as an external presentation that takes place on a location and within frameworks, set by the conservatory;
- As a condition for taking the exam, the student must compile a written reflection (5 standard pages), containing:
  1. An account of the individual artistic considerations and choices in relation to the presentation;
  2. An account of the collective artistic considerations and choices in relation to the presentation;
  3. A description of the collective group work process towards the presentation, hereunder considerations about choice of methods;
  4. A description of the student’s own role in the collective presentation – with what has the student contributed in terms of performing, creating, producing aso;
  5. A description of the student's individual learning process in the collective process;
  6. A description of how the music, presented at the concert is contributing to develop the field in which the music is positioned.
- The written reflection must at the latest be submitted approximately two weeks prior to the examination. The precise deadline for submission will be set by the Study Administration and stated in the relevant course plan.

***Subject description: Music Performance (MP)***

For the performing rhythmic musician, it is essential having developed an independent artistic expression and a strong performative profile, which will comprise the core of the future professional practice.

In the subject Music Performance, the development of the student's performative profile is supported by developing the student's skills and knowledge within this field.

Subject-specific spaces are established, in which the student is given the opportunity to immerse into explorations of various performative topics, in collaboration with experts of these specific areas.

The student's development in the subject is viewed in close association with studies in the subject Artistic Development Work.

**Learning Outcomes**

At the conclusion of the teaching in Music Performance in the second semester, the student must, at an advanced level:

- Possess performative skills, that develop and support the student's artistic profile as a performing musician;
- be able to apply and develop artistically qualified formats for performance and presentation, supporting the artistic profile of the student;
- possess knowledge of methods and practices within the performative area;
- be able to independently engage in professional and interdisciplinary collaborations and networks;
- be capable of identifying own learning needs and independently acquiring new knowledge and skills.

**Content**

Each semester, the conservatoire offers courses, taking their starting point in specific explorations of topics within the following areas:

- Stage performance and interaction with the audience
- Performance practices, solo performance and collective performance
- Performance formats, based on New Tech – AI, VR, AR and similar.
- Interdisciplinary performance aspects

### **Requirements for participation**

None.

### **Assessment**

- Semester assessment I, ultimo 1<sup>st</sup> semester
- Semester assessment II, ultimo 2<sup>nd</sup> semester

At the conclusion of each semester, the student's qualifications are assessed in terms of the student's active subject-specific participation in the course.

Assessment is undertaken by the teacher in accordance with the stated module criteria for active subject-specific participation, and will be carried out within a deadline, set by the Study Administration and stated in the relevant course plan for the subject.

The assessment awarded is: Approved/Not approved.

***Subject description: Entrepreneurship (ES)***

The subject Entrepreneurship contributes to developing the student's ability to apply his/her creative and artistic skills into sustainable employment.

The subject concentrates on enhancing the student's ability to combine knowledge with opportunities, and thereby create value. The focus is on generating ideas, which encompasses creativity and the ability to recognise opportunities and sources of innovation, with a view to creating artistic and/or commercial value for oneself and others. Entrepreneurship is a fundamental element in the student's career management, and the subject has been included in the study programme in order to strengthen the student's ability to create progress and value in a changing employment market.

The subject links to the programme's other disciplines, provides an understanding of interdisciplinary work in particular and of innovation processes more generally and constitutes the academic foundation for working with entrepreneurship as part of the External, Integrated Module in 3<sup>rd</sup> semester.

**Learning outcomes**

At the conclusion of the teaching in Entrepreneurship in the second semester, the student must, at an advanced level:

- possess skills in relation to creating and strengthening the graduate's employment as a creative and performing musician;

The tuition alternates between theoretical studies and practical application, on the basis of the student's own practice.

Through a broad, interdisciplinary range of courses, the optional subject focuses on developing the students' professional skills through specialised optional modules located within or outside the range of subjects offered by the study programme, and which continue throughout the study programme.

The student's development in the subject is viewed in association with his or her progression in the main area of the study programme, Artistic Development Work.

### **Learning outcomes**

At the conclusion of the teaching in Electives in the fourth semester, the student must, at an advanced level:

- possess musical, instrumental/vocal and other professional skills that develop and support the student's artistic profile as a creative and performing musician;
- possess knowledge that develops and supports the student's artistic profile as a creative and performing musician;
- be capable of taking independent responsibility for his or her own professional development and specialisation.

### **Content**

*1<sup>st</sup> and 2<sup>nd</sup> Semester*

The Conservatory offers interdisciplinary courses in a wide range of subject areas.

The teaching content typically lies within the areas of instrumental/vocal tuition, ensemble playing, stage performance, composition, arranging, song-writing, improvisation, music technology, music education, industry knowledge and reflection.

The learning outcomes and forms of instruction and work of the course modules, together with the criteria for approval, are described in the relevant course plan.

Students, in dialogue with their supervisor, compile their own individual portfolios, consisting of one or two modules per semester.

*4<sup>th</sup> Semester*

***Subject description: External Integrated Module (EIM)***

For the creative and performing musician, it is of crucial importance to his or her future professional work with a sustainable career in a changeable job market to be able, independently and in collaboration with others, to formulate, initiate and realise artistic projects in a professional, interdisciplinary context, and be able to take personal responsibility for one's own professional development and specialisation.

The external integrated module integrates the disciplines Artistic Development Work (ADW), Music Performance (MP), Entrepreneurship (ES) and Electives (VALG) into a single project that is realised externally in a professional context in which the student further develops his or her independent artistic practice and performative and creative profile, develops and applies entrepreneurial knowledge and skills on the basis of the student's own practice, and refines other relevant professional skills that can support the student's academic profile.

**Learning outcomes**

At the conclusion of the teaching in the External Integrated Module in the third semester, the student must, at an advanced level:

(ADW-MP-VALG)

- be capable of creating, performing and communicating music and musical experiences borne by an independent artistic expression;
- possess musical, instrumental/vocal and other professional skills that develop and support the student's artistic profile as a creative and performing musician;
- possess the ability to make and justify individual and collective choices in relation to creative and/or performance products;
- possess knowledge that develops and supports the student's artistic profile as a creative and performing musician;
- possess knowledge of method and practice within artistic development work;
- be able to carry out artistic development work, based on research questions;
- be able to place his or her own artistic practice in a national and international context;

## Examination description

### *Content*

The examination consists of two parts – presentation and interview:

- Presentation: The student plays digital documentation representing the artistic result of the module.
- Interview: The examination panel asks questions relating to the student’s project folder and presentation.

### *Duration*

- Presentation 20 minutes
- Interview 15 minutes
- Assessment process, including disclosure of examination result and clarification of the reasons for this 15 minutes.

### *Assessment*

- A grade from the seven-point scale is awarded for the music performance presentation, and a further grade from the seven-point scale for the professional entrepreneurial presentation.  
In order to pass the exam, both parts of the exam must be passed separately.
- The assessment basis consists of the student’s project folder, presentation and interview.
- The assessment is based on an evaluation of the extent to which the examination performance meets the learning outcomes for the subject.
- In the assessments, particular emphasis is placed on the student’s artistic and academic standard, the student's ability to plan, implement and evaluate a project with an investigative nature, the student's skills in relation to creating and strengthening their employment as a creative and performing musician, and the student's ability to enter into collaborations with external partners.

### *Examination panel*

Common internal expert (Artistic Development, examination supervisor), common internal expert (Artistic Development) and common internal expert (Entrepreneurship).

Pursuant to section 13 of the Assessment Order, one common internal expert (Artistic Development), examination supervisor) acts as “moderator”, and the other two common internal experts as “examiners”.

    8. Process account, in which the student describes the actual events, external collaborations and networks during the module, including a description of and justification for any changes made during the module;
    9. Brief explanation of the student's overall outcome of the module.

The project folder must at the latest be submitted approximately two weeks prior to the examination. The precise deadline for submission will be set by the Study Administration and stated in the relevant course plan.

***Subject description: Masters Project (KA-proj)***

For the creative and performing musician, it is crucial to possess knowledge and skills in independent project work.

The Masters Project is the concluding project in the study programme, in which the student independently develops and carries out a major concert project.

In the Masters Project, the student studies a subject of the student's own choice which falls within the main area of the study programme, Artistic Development.

In this work, students apply and utilise their overall professional skills, knowledge and competencies.

The student is thus provided with an opportunity to implement a project that can serve as an indicator in relation to the student's future career.

**Learning outcomes**

At the conclusion of the Masters Project in the fourth semester, the student must, at an advanced level:

- be capable of creating, performing and communicating music and musical experiences borne by an independent artistic expression;
- possess musical, instrumental/vocal and other professional skills that develop and support the student's artistic profile as a creative and performing musician;
- possess knowledge of methods and practice within live performance;
- be able to apply artistically qualified formats for performance and presentation, supporting the artistic profile of the student;
- possess the ability to make and justify individual and collective choices in relation to creative and/or performance products;
- possess knowledge that develops and supports the student's artistic profile as a creative and performing musician;
- possess knowledge of method and practice within artistic developmental work;
- be able to place his or her own artistic practice in a national and international context;
- be able to reflect critically on artistic processes and results;
- be capable of handling communication activities in relation to colleagues and non-specialists on the basis of his or her own artistic development;
- be able to formulate, initiate and implement professional and interdisciplinary tasks and projects in a professional context, both independently and in collaboration with others;
- be able to plan and carry out complex developmental tasks that demand new and innovative solutions;
- be capable of giving and receiving professionally-based criticism in relation to both working processes and products;
- be capable of taking independent responsibility for his or her own professional development and specialisation.

- Live performance, developing and planning of a major concert performance event included;
- Creative artistic activities, including instrumental skills, composition, interpretation, arranging and communication;

- Interview: An interview in which the test panel asks questions relating to the student's project folder and concert.

- Final assessment process and disclosure of the examination result and clarifications of reasons for this 30 minutes.

- In the assessment, special emphasis is placed on the student's artistic level.
- The written statement addresses the student's artistic and academic level, and consists of two elements:
  1. Brief statement on the project folder
  2. Brief statement on the concert.

### ***Examination panel***

The examination panel consists of a common external common expert and two common internal experts, one of whom acts as the examination supervisor.

Pursuant to section 13 of the Assessment Order, the common external expert acts as "moderator", and the first common internal expert and the second common internal expert (the examination supervisor) act as "examiners".

### ***Form***

- Individual examination, organised such that the interview and final assessment, including disclosure of the examination result, take place the day after the presentation.
- The student is responsible for ensuring the presence of any desired accompanists at the examination.
- As a condition for taking the examination, the student must compile a project folder. The project folder must at the latest be submitted approximately two weeks prior to the examination. The precise deadline for submission will be set by the Study Administration and stated in the relevant course plan.
- The project folder must include:
  1. An approved project description, containing:
    - The project title
    - Reasoned artistic goals
    - Working methods
    - Academic guidance – reasoned needs and wishes
    - Work schedule, indicating specification of the distribution of working hours
    - Requirements in relation to participants, facilities, special equipment, etc.
  2. A recording of 30 minutes of music, for which the student is artistically responsible and which in its substance derives from the project. Delivery format: Audio: WAV, AIFF, MP3; video: QuickTime, MPV4.
  3. Project report, which must include:
    - An account of the artistic considerations and choices during the project, hereunder any changes in the artistic goals of the project;
    - Reflections about where the project is placed in a national and international context;
    - Description of the student's artistic and academic outcomes from the project process;
    - Description of the student's reflections on further artistic development.
